Students who visit the nurse and present any of the COVID-19 symptoms listed above who are not tested will be presumed positive for COVID-19 and excluded from in-person learning and CCPS activities for 10 calendar days."

#### Elementary Cell Phone Rule

As many of our students' parents desire them to have a cell phone for safety reasons, please note the CCPS rule regarding cell phones at school for elementary students.

CCPS allows the possession and use of cell phones and other personal electronic devices by students. It is the intent of the Superintendent to ensure that this allowance does not disrupt the learning environment, after-school activities, or the safe transportation of students. Students are permitted to use cell phones while attending (but not participating in) general public events that occur after hours and are open to the community.

The following conditions outline the standard expectations for the possession and/or use of cell phones and electronic devices by students at school, on the bus or on other school-chartered vehicles.

Elementary school students: Students may only bring their phone or device, with a written request from the parent or guardian for a specific (non-social) purpose, and upon receipt of written approval from the principal.

Once approved, student must keep their phone or device powered completely off (not on vibrate or silent mode) and inside their book bag, locker or cubby throughout the entirety of each school day, unless other storage arrangements are made with the teacher.

Once approved for school, students may use their phone or device on the bus or school-chartered vehicle, but use must not be disruptive or cause a distraction to the driver at any time; examples include: phone conversations, loud music, videos or electronic games.

At Matula, device storage arrangements have been made in the main office. The student must drop off the phone in the office upon arrival and pick it up at dismissal.

## Charles County Public Schools COVID-19 Pre-screening Questionnaire

For 2021/2022 School Year 9-8-2021

#### Dear Parents and Guardians:

To ensure the highest level of health and safety in Charles County Public Schools (CCPS) buildings, we ask all parents to report their child's health status before coming to school. We are implementing safety measures beyond cleaning and sanitizing as we allow more employees and children into our schools.

We need your help to check your child's health each morning before they enter school. By sending your child to school, you indicate you have screened your child, and he/she is not a potential positive COVID-19 case. A child who has tested positive for COVID-19 in the past 10 days, who is suffering from an upper or lower respiratory illness, or has had close contact with an ill person who has tested positive for COVID-19 should stay home.

"COVID exposure" is defined as being within six feet of a positive person for more than 15 minutes during a 24 hour period. Close contact would also include sharing a drink or utensils, kissing, hugging, or a sick person coughing or sneezing directly on you.

People with COVID-19 have reported a wide range of symptoms. According to the Centers for Disease Control and Prevention (CDC), children with the below symptoms may have COVID-19. The most common symptom of COVID-19 for school aged children is a fever and cough. If your child displays ANY of the COVID symptoms listed below, your child should stay home and your family medical care provider should be contacted.

New uncontrollable cough	Y/N
Fever (over 100.4) or higher	Y/N
New onset of severe headache, with a fever of over 100.4	Y/N
Sore throat with visible redness	Y/N
Difficulty breathing	Y/N
Vomiting	Y/N
Diarrhea	Y/N
New loss or change in your ability to taste or smell	Y/N

We will ask parents to remove any child from the center and school building within 60 minutes if they become ill.

If your child presents symptoms associated with COVID-19, please contact your family medical provider immediately. If your child tests positive for COVID-19 and they have been to school within the four days before the test or displaying symptoms, please contact the school immediately.

Students may not return to school for at least 24 hours after they no longer have a fever or other symptoms without the use of medicines.

Parents who knowingly send children suffering from any of the COVID-19 symptoms are jeopardizing the health of other students and staff. Students sent home by the nurse with COVID symptoms may not return to in-person instruction or school activities unless they receive a negative PCR test. Students who visit the nurse and present any of the COVID-19 symptoms listed above who are not tested will be presumed positive for COVID-19 and excluded from in-person learning and CCPS activities for 10 calendar days.

CCPS, in partnership with the Charles County Department of Health, has purchased re-usable thermometers. Each household can receive up to two thermometers per student. If you need a thermometer, please contact your school.



### **2021 Early Fall Assessments**



#### **Overview of Early Fall Assessments**

As part of continued COVID-19 recovery efforts, the Maryland State Department of Education is conducting an early fall student assessment as one of several strategies to identify how students are performing academically. The results will help educators better understand student needs, so that we can address disrupted education and accelerate learning opportunities for all students. These results never stand alone in assessing student growth, and will be used in combination with other assessments and class work to gauge overall student performance.

#### What is MCAP?

The Maryland Comprehensive Assessment Program (MCAP) is the overarching term used for all state assessments. MSDE will administer assessments in the Early Fall for English Language Arts/Literacy (ELA/L), Mathematics, and Science (Maryland Integrated Science Assessment-MISA), as well as the Alternate Assessments in ELA, Mathematics and Science, and the Kindergarten Readiness Assessment (KRA). The MCAP also includes assessments in Social Studies and the ACCESS for ELLs assessment for English language learners.

#### What is different this year?

#### SHORTER ASSESSMENTS

Each Early Fall assessment is a shorter version of the traditional ELA/L, Mathematics, and MISA assessments which will measure how well students performed in content presented during the last school year (2020-2021). Students will take the assessment for the grade or course in which they were enrolled last Spring when the assessment was postponed due to the COVID-19 pandemic. For example: a current 4<sup>th</sup> grader will take the 3<sup>rd</sup> grade English Language Arts/Literacy (ELA/L) or Mathematics test, and a current 9<sup>th</sup> grader would take the 8<sup>th</sup> grade MISA assessment.

#### **COVID-19 WAIVER**

High school students who were enrolled in an ELA/L 10, Algebra I or High School Science course last year and take the shorter Early Fall assessment will not be required to pass the assessment to meet Maryland's graduation requirements. Additionally, during the 2021-2022 school year, students enrolled in an ELA/L 10, Algebra I, Biology or Life Science, or Government course will be required to take, yet not required to pass, the current assessments for graduation. Students must pass the respective course.

#### NO TESTS FOR 3RD GRADERS DURING THE EARLY FALL ASSESSMENTS

Students in 3<sup>rd</sup> grade will not test since it is content from the prior year that will be assessed.
