Dear Parents, Guardians and Staff:

In recent weeks, Charles County Public Schools (CCPS) has experienced higher than normal absentee rates for students. Many of these students are returning to school with doctor or parent notes that indicate they were out due to an illness. Illnesses among staff have also contributed to a higher request for substitute teacher coverage in recent weeks. According to our school nurses, student health office visits have increased as well for reports of fevers, headaches, coughs and stomach aches.

According to the Centers for Disease Control and Prevention (CDC), illnesses such as the flu, RSV (respiratory syncytial virus) and COVID-19 are common right now among both adults and children. I ask that if your child is exhibiting symptoms of any illness that you please keep them home from school and seek medical treatment.

Students should be fever free for 24 hours without the use of fever reducing medications before returning to school from any illness. When a student becomes sick at school, the school nurse or other staff member will contact the child's parent/guardian. If a parent or guardian is not reached, emergency contacts listed on the student emergency card will be called and required to pick up the student from school. Please make sure your contact information on file at your child's school is current, and that you notify school staff quickly of any changes. This will ensure you can be reached when your child becomes sick at school or in case of an emergency.

Parents of students who are sick should report their child's absence to the attendance secretary at their child's school. A written excuse note signed by a parent, guardian or doctor must be submitted to the school within five days of the child's return to school for the absence to be excused. If you are not sure who the attendance secretary is at your child's school, please contact a staff member in the main office to ask.

Some teachers may share such notes with the attendance secretary, but parents should not rely on teachers to submit the information on their child's behalf. Students who have verified excused absences (with parent/guardian or doctor note confirmation) are eligible to make up missed class work. Please reach out to your child's teachers or school principal for information about missed classwork and the expected timeline for completion and grading.

The Charles County Department of Health continues to host free vaccination clinics for children that offer both the COVID-19 and flu vaccines. Attached to this message is a list of upcoming vaccination clinics sponsored by the health department. Please consider talking to your family doctor about vaccination options for your child. Please remind your child about healthy habits, such as proper hand washing, getting quality sleep and eating healthy foods.

I appreciate the support of all parents, staff and students, and our health care providers and school nurses. If you have any questions or need medical assistance for your child, please contact your family doctor or call the health department at 301-609-6900.
